

**Please do NOT staple/clip/tab documents**

The following is an outline of application procedures for nationals of Russia who wish to apply for a multiple-entry visa as a temporary visitor. This visa is for the purpose of tourism OR visits to relatives/acquaintances. Holders of this visa are not permitted to perform activities to undertake revenue generating business operations or activities to receive remuneration while in Japan. Multiple-entry visas may be issued to applicants with a sufficient level of financial capability and their families.

**Conditions/Eligibility:**

- (1) The length of stay for the visa will be 30 days for each visit.
- (2) The applicant has visited Japan at least **once** during the last three (3) years and has sufficient financial capacity or is employed and is earning sufficient income.
- (3) The applicant must have financial documents under his/her name. If the applicant does not have any financial documents, the person whose name is on the financial documents must already have a Multiple entry Visa to Japan **or** must apply for a multiple entry visa at the same time.

\*Visa applications must be submitted by mail or drop-off. There is NO in-person application process.

\* Please do **NOT** staple or clip your documents. All documents must be originals and written in English or Japanese.

\* If necessary, additional documents may be required other than the documents listed above.

\*Please be advised that you may be issued a single entry visa upon visa application examination.
