

Checklist for Single-Entry Short-Term Stay VISA(Visiting Friends/relatives)

Purpose of **Visiting Friends/relatives only**

Please **do NOT** staple/clip/tab/put sticky notes on documents
YOU MUST APPLY WITHIN 3 MONTHS OF ENTERING JAPAN

1	Valid Passport	Valid Passport with at least one completely blank visa page.
2	Proof of your U.S. Immigration Status	Copy of U.S. VISA (Please submit copies only. 3	Visa Application Form (SAMPLE)	*Nationals of Russia, Ukraine, Belarus, Georgia and other NIS nationalities MUST submit TWO Application Forms. *Name must be written in at least English AND ALSO Chinese characters, if applicable. ✓ Your signature must match your passport signature. ✓ Please include E-MAIL address on form. ✓ Must include your intended date of departure from the U.S. and the dates of arrival and departure for Japan.
4	Facial Photo	ONE passport style photo (2"x2" or 2"x1.4") on glossy photo paper taped to the application form. *Nationals of Russia, Ukraine, Belarus, Georgia, and other NIS nationalities MUST submit TWO identical photos ✓ Must be taken within 6 months ✓ Do not use photo apps that may alter your facial image ✓ Using plain background facing forward showing full face, head and top of shoulders, no glasses
5	Confirmed or Tentative Flight Itinerary (Round Trip)	Please submit ALL flights information below. 1. Flight itinerary from United States to Japan 2. Flight itinerary from Japan to United States (or your final destination). FLIGHT ITINERARY must be from an airline or travel agency, and MUST SHOW the following: Your full name as a passenger, flight number, airport names, dates, and times of departure and arrival. * For example, if you travel from United States to China first, China to Japan, and Japan to China, please submit all flight itineraries starting from United States.
6	Schedule of Stay	Please write your daily schedule and hotel information including address & phone numbers (See page 2)
7	Financial Documents	<u>APPLICANT'S MOST RECENT U.S. BANK STATEMENT</u> showing sufficient funds * U.S. Bank statement must show your full name, current balance, partial account number. * Issued within the last 30 days, both Checking and Saving Accounts. * Funds must be in US currency and your financial institution must be local
8	Invitation Letter	INVITATION LETTER in <u>English</u> or <u>Japanese</u> from relative/friend living in Japan if you will stay at their residence.
9	For Spouse and/or Child Applicants	<input type="checkbox"/> Copy of Marriage Certificate w/translation by professional <input type="checkbox"/> Copy of Birth Certificate w/translation by professional
10	Proof of Residence	Submit ONE of the following to match with your current address in our <u>jurisdiction</u> : <input type="checkbox"/> COPY of your valid California/Nevada Driver's license/ID card (Copies must be clear and legible) <input type="checkbox"/> Most recent utility bill, bank statement, health insurance bill, or valid lease agreement (if recently moved) showing your full name, current address and statement date. * You must live within our <u>jurisdiction</u> to apply through our office. (Northern and Central California & Nevada)
11	VISA FEE	Exact amount in MONEY ORDER made payable to "Consulate General of Japan". For money orders, please write in PRINT LETTERS applicant's full name in the FROM field. CASH accepted for Drop-off only. NO personal checks accepted.
12	Release of Liability	ONE Completed <u>Release Of Liability</u> (see page 3)
13	Prepaid USPS Return Envelope	PREPAID USPS SELF-ADDRESSED RETURN ENVELOPE with tracking number. Service must be USPS (US Postal Service) Only. *Priority Mail or Priority Express Mail is strongly recommended. Please keep your tracking number information on your end to track. We are not able to return by FedEx, UPS, or DHL. Passports cannot be picked up in-person.

- * Visa applications must be submitted by mail or drop-off. There is NO in-person application process.
- * We take a **minimum of 5 business days** to process with sufficient documents. We do not have expedited services.
- * Please do **NOT** staple/clip/tab/put sticky notes on documents. All documents must be written in English.
- * This visa is valid for 3 months once issued to enter Japan.
- * Please submit a set of documents for each applicant. You may not share your documents. We do not make copies.
- * If necessary, additional documents may be required other than the documents listed above.
- * Applications from those who entered the U.S. with a B1/B2 visa or who are under a U.S. visa exemption status will not be accepted.
- * 6 month validity is required for US re-entry permit or US refugee travel document holders who wish to travel Japan.
- * All documents must be written in English or Japanese.
- * Please note that we issue only single entry visas for these types of travel documents.
